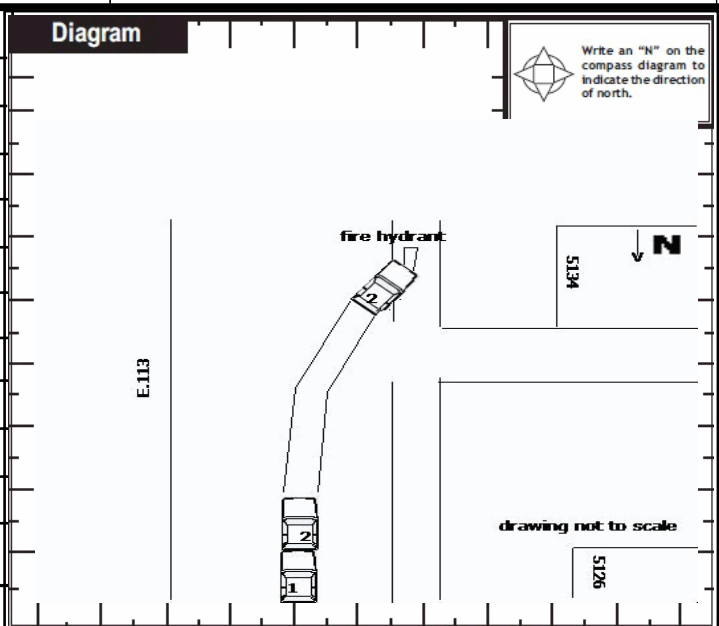

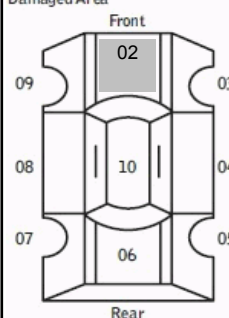
UNIT 2 WAS STOPPED IN FRONT OF 10801 THORNTON BY UNIT 1 FOR A TRAFFIC STOP. UNIT 2 THEN PROCEEDED TO DRIVE OFF IN A CARELESS MANNER EAST ON THORNTON, THEN NORTH ON E.112TH, EAST ON MCCrackEN, SOUTH ON E. 113 WHERE UNIT 2 STRUCK A FIRE HYDRANT IN FRONT OF 5134 E. 113TH. THE DRIVER OF UNIT 2 EXITED THE VEHICLE AND TOOK OFF RUNNING. UNIT 2 WAS NOT IN PARK AND ROLLED BACKWARDS STRIKING UNIT 1 WHICH HAD PARKED IN FRONT OF 5126 E.113 AND WAS UNOCCUPIED.

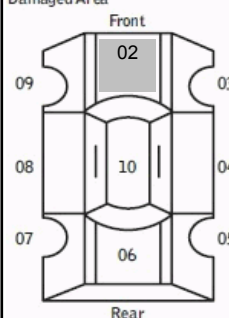
