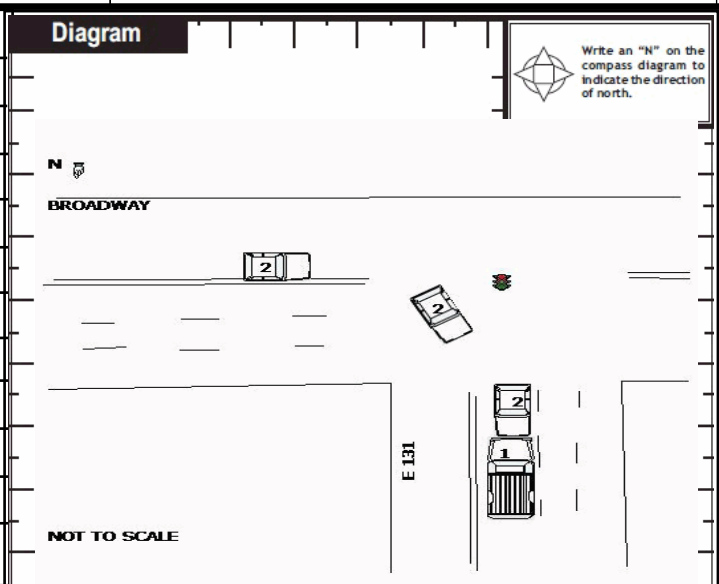

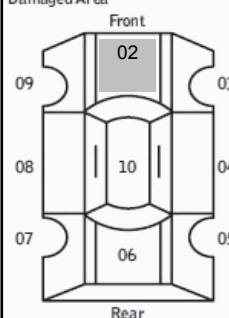

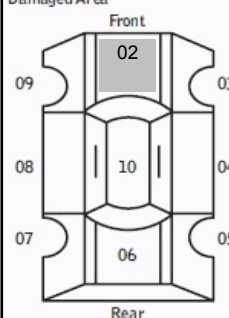

 UNIT 1 WAS STOPPED ON E 131 AND BROADWAY AT A RED LIGHT. UNIT 2 WAS W/B ON BROADWAY, TRAVELLED LEFT OF CENTER AND MADE AN IMPROPER RIGHT TURN FROM FAR LEFT LANE. UNIT 2 THEN FAILED TO CONTROL HER VEHICLE, WAS LEFT OF CENTER AND STRUCK UNIT 1 HEAD ON. UNIT 2 WAS APPARENTLY AVOIDING A MARKED TRAFFIC GHPD UNIT WHICH WAS NOT IN PUSUIT OF UNIT 2.
