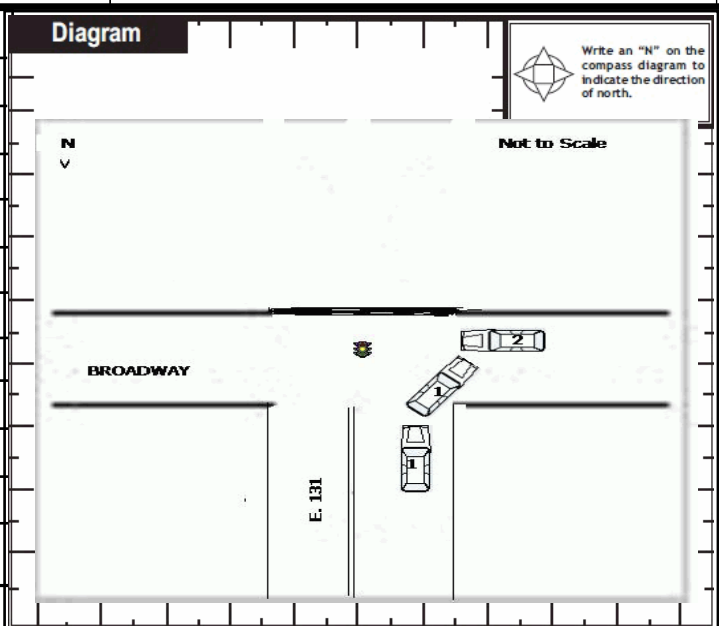

UNIT 1 WAS TRAVELLING SOUTH ON E.131 APPROACHING BROADWAY AVE. UNIT 2 WAS AT THE INTERSECTION OF BROADWAY AVE AND E.131 FACING EAST, PREPARING FOR A LEFT TURN ONTO NORTHBOUND E.131. AS UNIT 1 APPROACHED THE INTERSECTION, UNIT 1 ATTEMPTED A RIGHT TURN ONTO WESTBOUND BROADWAY AVE. UNIT 1 LOST CONTROL DURING THE TURN, WENT LEFT OF CENTER AND STRUCK UNIT 2.
