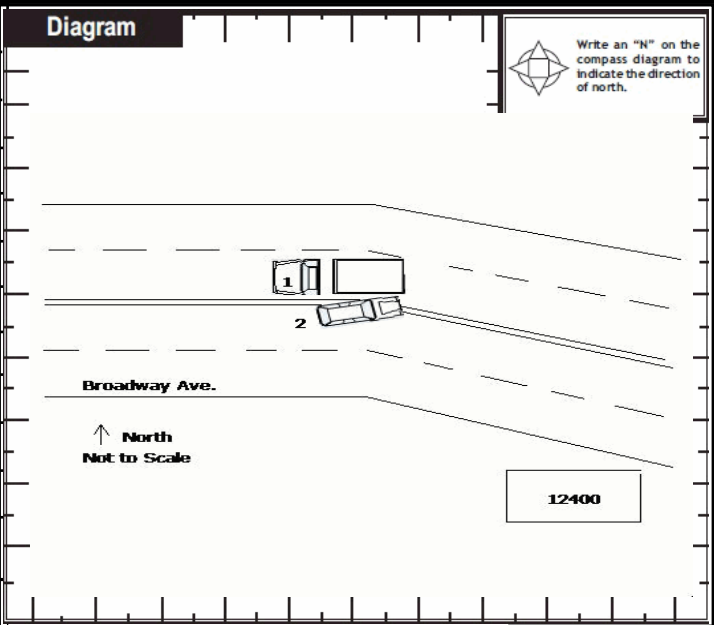



 UNIT 1 WAS A TRACTOR/ SEMI-TRAILER UNIT AND WAS TRAVELING WEST ON BROADWAY AVE. IT HAD JUST PASSED THE ADDRESS OF 12400 AND WAS APPROACHING HENRY ST. UNIT 2 WAS EASTBOUND ON BROADWAY AND HAD PASSED HENRY ST. APPROACHING 12400. THE DRIVER OF UNIT 2 FAILED TO CONTROL THE VEHICLE AND UNIT 2 DRIFTED LEFT OF CENTER INTO UNIT 1'S LANE. UNIT 2 STRUCK UNIT 1 IN THE TRAILER AREA CAUSING HEAVY DAMAGE.
