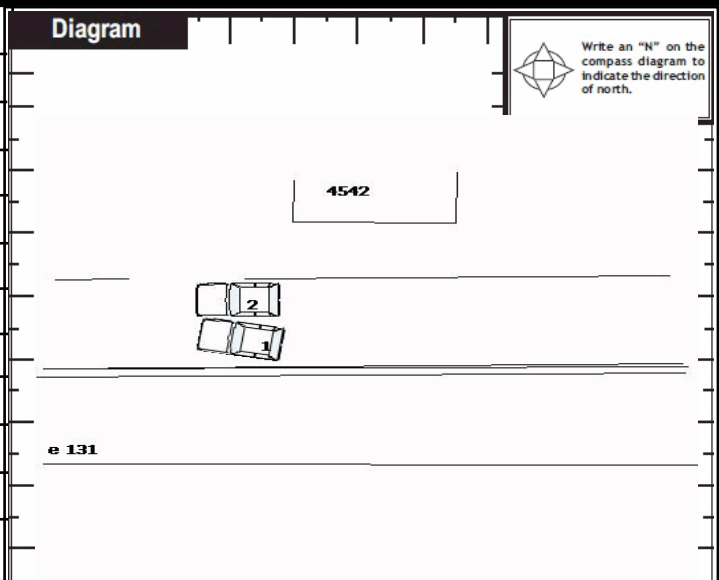





UNIT 2 STATED UNIT 1 DID NOT USE A TURN SIGNAL AND HE TURNED FROM FAR LEFT OF LANE. DRIVER OF UNIT 1 STATED HE USED TURN SIGNAL AND THAT EVEN THOUGH IT IS A WIDE LANE IT IS ONLY 1 LANE ROAD. OFFICER REVIEWED VIDEO BUT IT WAS INCONCLUSIVE.
