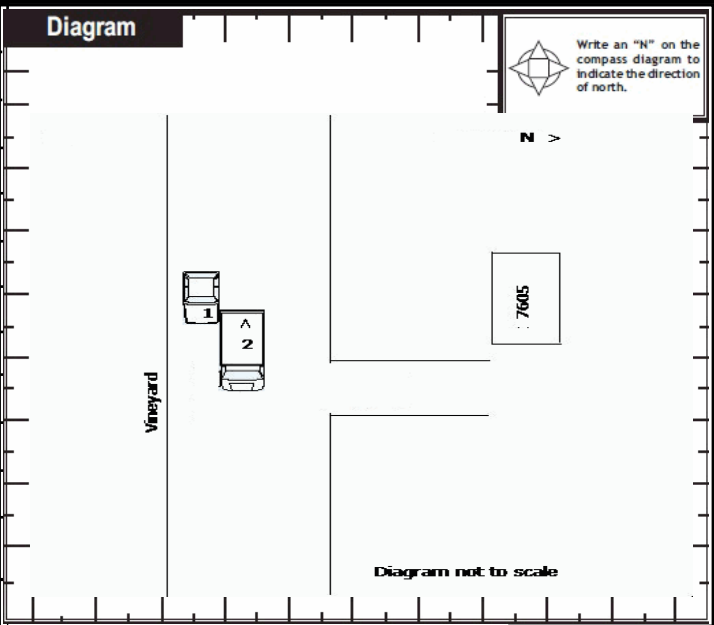

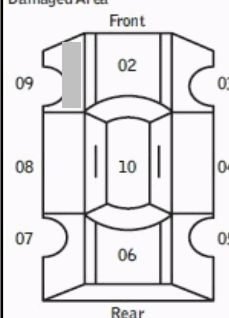

 DRIVER OF UNIT 1 STATES HE WAS PARKED IN THE ROADWAY IN FRONT OF 7601 VINEYARD AND OBSERVED UNIT 2, A FLAT BED TOW TRUCK, TURN AROUND IN A DRIVEWAY EAST OF WHERE UNIT 1 WAS PARKED. THE TOW TRUCK BEGAN BACKING TOWARD UNIT 1 SO HE PULLED FORWARD IN AN ATTEMPT TO GIVE THE TRUCK MORE ROOM TO REVERSE DOWN THE STREET. UNIT 1 STOPPED JUST EAST OF 7605 IN THE ROADWAY AND AS UNIT 2 BEGAN TO REVERSE PAST UNIT 1 IT STRUCK THE FRONT LEFT FENDER OF UNIT 1. SEVERAL ATTEMPTS WERE MADE TO CONTACT THE OWNER OF UNIT 2 ON 11-9-17 WITH NEGATIVE RESULTS.
