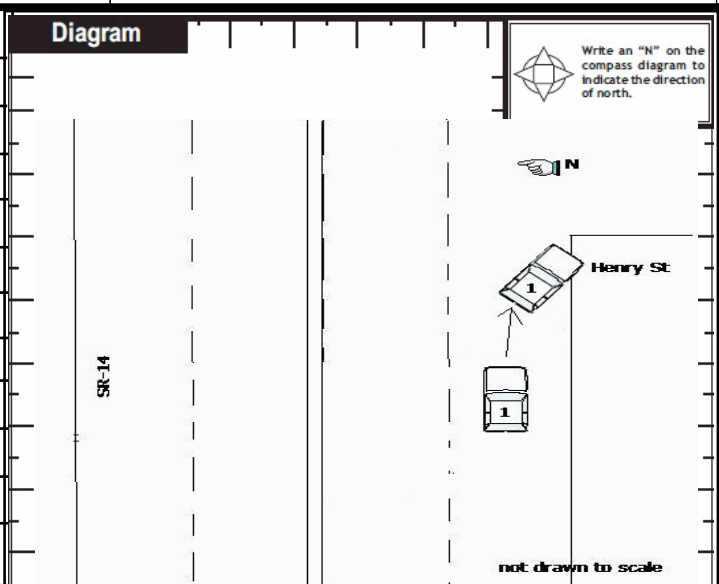

UNIT #1 WAS TRAVELING EAST ON SR-14 AT HENRY ST.

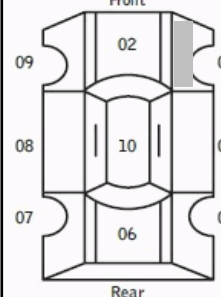
