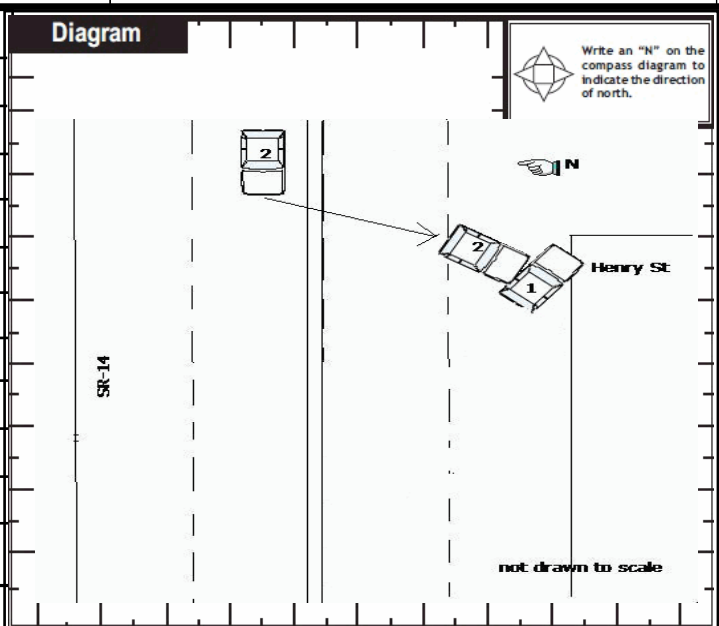


Narrative
