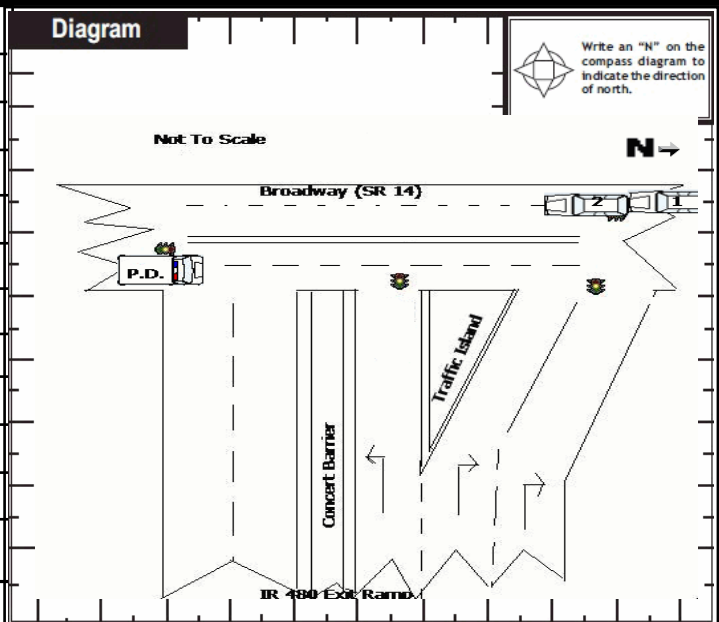

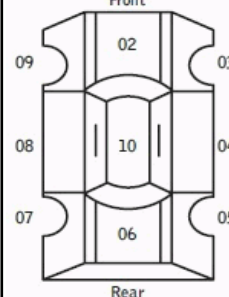
Narrative

THE OPERATOR OF UNIT #2 WAS TRAVELING E/B ON BROADWAY (OUTSIDE LANE) AND SLOWED AT THE INTERSECTION OF BROADWAY AND I480 AS AN EMERGENCY VEHICLE WAS APPROACHING W/B ON BROADWAY. UNIT #1 WAS ALSO TRAVELING E/B ON BROADWAY, DIRECTLY BEHIND UNIT #2. AS UNIT #2 SLOWED, UNIT #1 DID NOT LEAVE ENOUGH DISTANCE BETWEEN VEHICLES. THIS CAUSED THE FRONT-END OF UNIT #1 TO STRIKE REAR-END OF UNIT #2.
