UNIT # 1 WAS SOUTHBOUND ON E. 104TH ATTEMPTING TO PROCEED THROUGH THE INTERSECTION. UNIT # 2 WAS EASTBOUND ON MCCRACKEN, WHEN IT FAILED TO STOP AT THE STOP SIGN AND STRUCK BOTH UNIT # 1 AND WESTBOUND UNIT # 3. UNIT # 2 THEN LOST CONTROL, AFTER THE IMPACTS AND WENT OFF THE LEFT SIDE OF THE ROADWAY AND STRUCK A UTILITY POLE. THE DRIVER THEN EXITED THE VEHICLE AND FLED THE SCENE.
