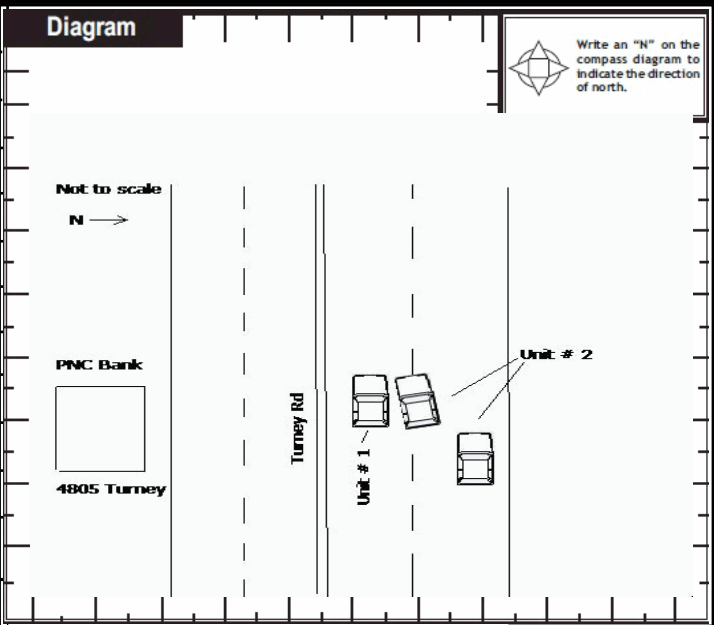





 DRIVER OF UNIT # 1 STATED HE TURNED SOUTH ONTO TURNEY RD. FROM PARK DRIVE AND MAINTAINED HIS POSITION IN THE CENTER LANE, DRIVER OF UNIT # 1 STATED THAT UNIT # 2 WAS NEXT TO HIM IN THE CURB LANE, THEN AND CAME OVER INTO HIS LANE, STRIKING HIS RIGHT FRONT. DRIVER OF UNIT # 2 STATED HE ALSO TURNED SOUTH ONTO TURNEY FROM PARK DRIVE, AND ENTERED THE CURB LANE. DRIVER OF UNIT # 2 STATED HE THEN CAME INTO THE CENTER LANE, TRYING TO GIVE SPACE TO VEHICLES THAT WERE PARKED IN FRONT OF BUSINESSES. DRIVER OF UNIT # 2 DID NOT SEE UNIT # 1 NEXT TO HIM, AND STRUCK UNIT # 1.
