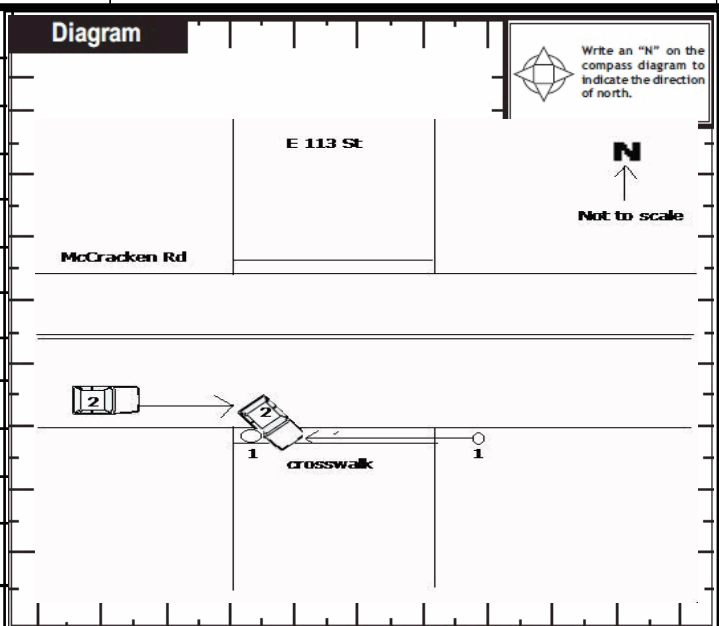

Unit one stated that she fell to the ground and the driver of unit two stopped and exited the vehicle to ask if she was okay. Unit one stated that the driver of unit two is the crossing guard who works at that intersection everyday. Unit one stated that she told her she was okay and got up and continued walking to school. Unit one stated that later her right leg and buttocks began hurting her and her mother was going to transport her to the hospital. Unit two was described as a white female with reddish hair in her fifties driving a grey or silver suv.</p> <p>A short time later I spoke with unit two who stated the following. The crash actually happened at McCracken and E 113. She stated that her side windows and the border of her windshield still had some frost on them which obstructed her view. She stated that she never saw unit one crossing. She stated as she made her right turn on to E 113 St. she heard a boom and saw that she hit unit one with her passenger side view mirror. Unit two stated that she stopped and made contact with unit one who said she was completely fine and continued to school.
