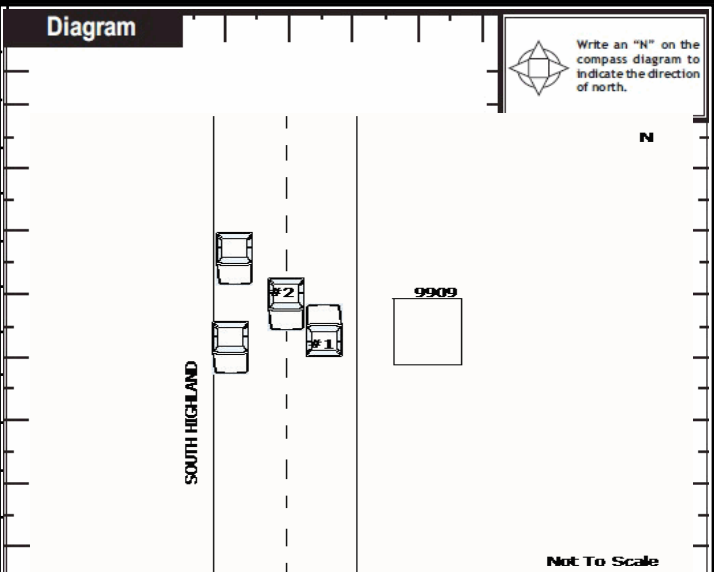


UNIT #1 WAS TRAVELING WEST ON SOUTH HIGHLAND
