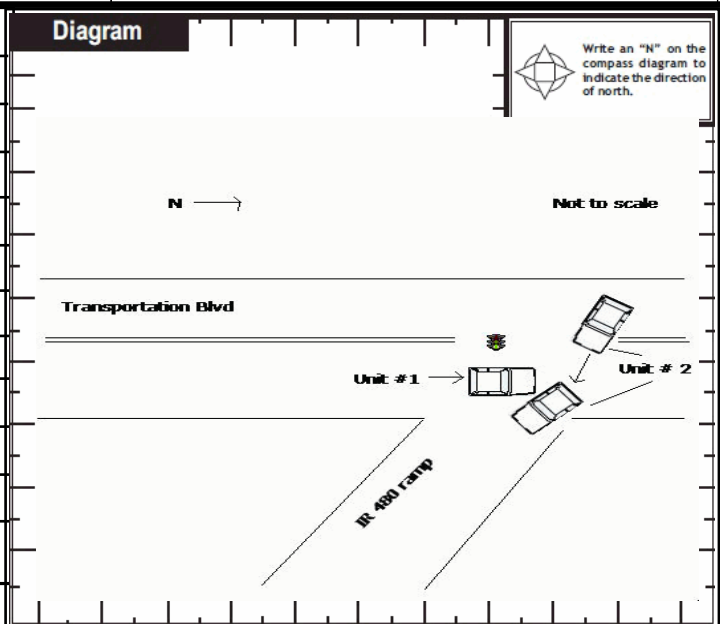

DRIVER OF UNIT # 2 STATED HE WAS TRAVELING SOUTH ON TRANSPORTATION AND TURNED LEFT TO GET ON IR480 WEST, AND STATED HE DID NOT MAKE THE TURN IN TIME, STRIKING UNIT # 1. BOTH UNITS HAD A GREEN LIGHT, UNIT # 2 FAILED TO YIELD TURNING LEFT.

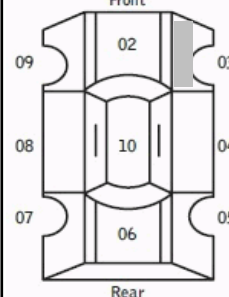
