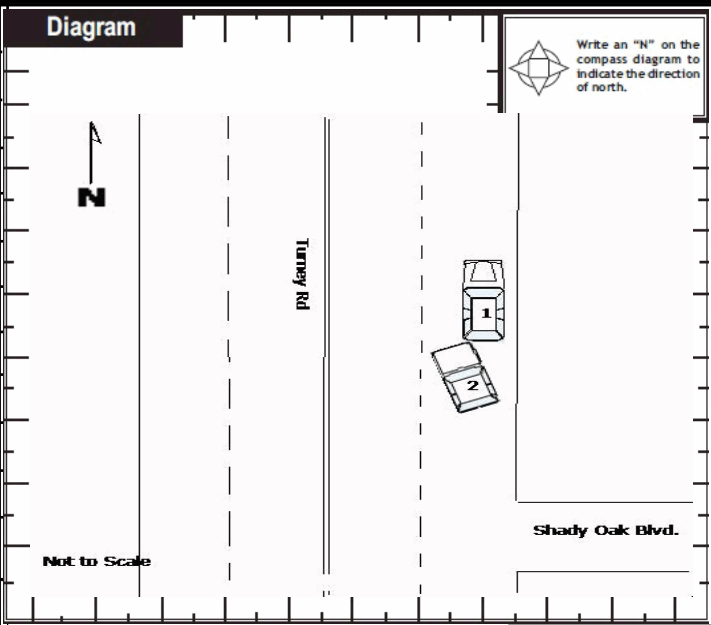





RAJA STATED THAT HIS WIFE DID NOT HAVE A DRIVERS LICENSE AND INSTRUCTED UNIT 2 TO STATE HE WAS THE DRIVER. RAJA REFUSED TO ALLOW THE FEMALE DRIVER TO BE IDENTIFIED.
