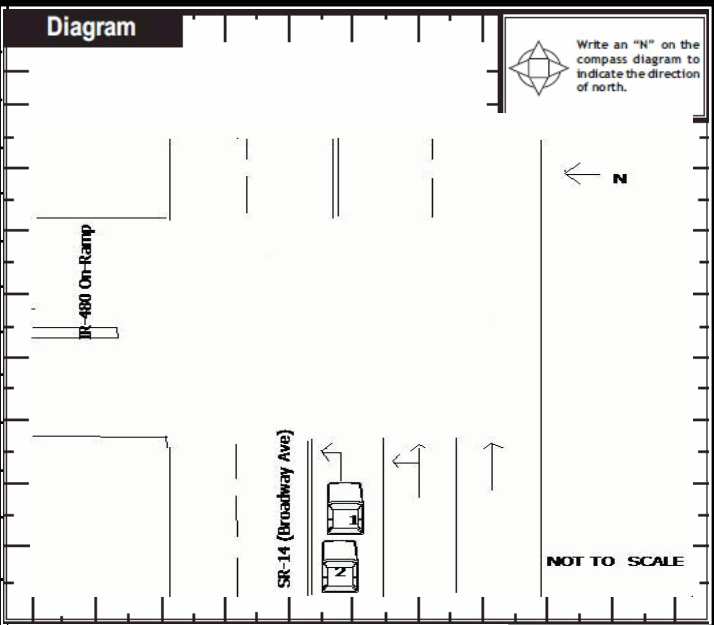

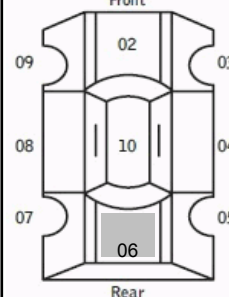
**Narrative**
