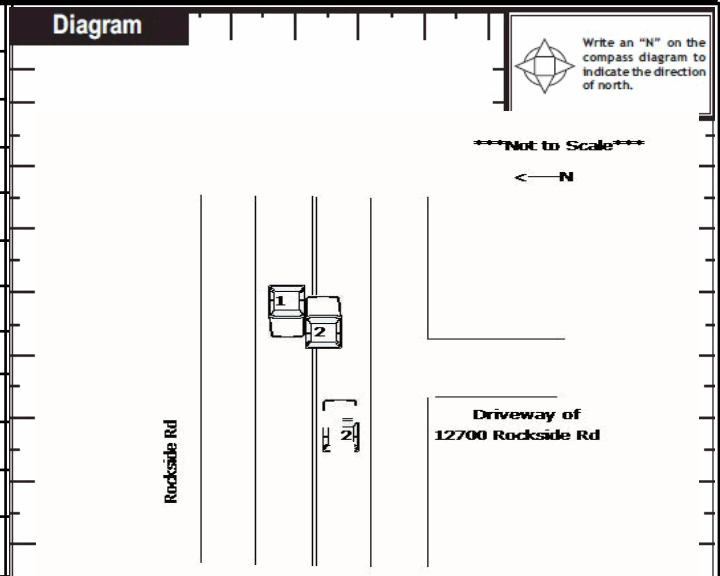

 DRIVER OF UNIT #1 STATED HE WAS TRAVELLING W/B IN FRONT OF 12700 ROCKSIDE ROAD IN THE CENTER LANE WHEN UNIT #2 DRIFTED LEFT OF CENTER AND INTO HIS LANE. WHEN THIS HAPPENED, THE DRIVER'S MIRROR OF UNIT #2 STRUCK THE DRIVER'S MIRROR OF UNIT #1, BREAKING BOTH OF THEM. ALSO, THE MIRROR OF UNIT #1 WAS PUSHED INTO THE DRIVER'S WINDOW CAUSING IT TO BREAK. DRIVER OF UNIT #2 STATED SHE WAS UNSURE IF SHE DRIFTED LEFT OF CENTER WHILE TRAVELLING E/B ON ROCKSIDE ROAD, BUT AN INDEPENDENT WITNESS STOPPED HER AFTER THE CRASH AND TOLD HER SHE DID. SHE BELIEVES SHE DID.
