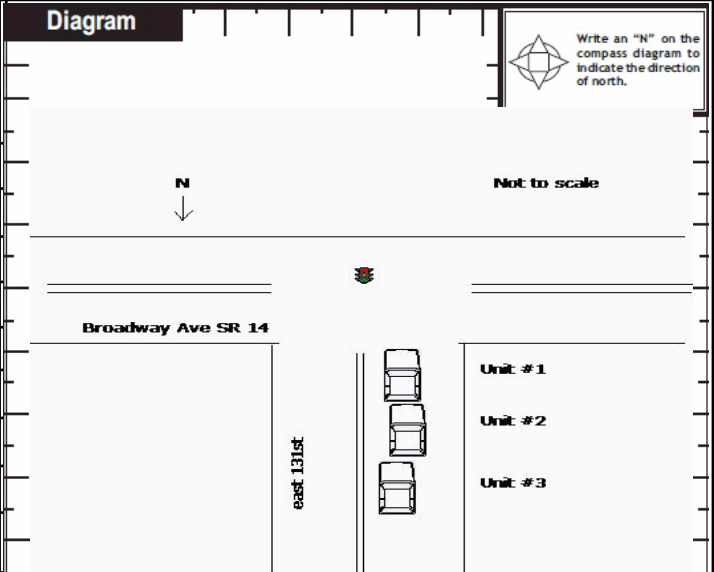

 DRIVER OF UNIT # 2 RESPONDED TO THE STATION AND STATED HE WAS SOUTH ON EAST 131ST AND STOPPED AT THE TRAFFIC LIGHT AT BROADWAY AVE WHEN HE WAS STRUCK FROM BEHIND BY UNIT # 3, AND WAS THEN PUSHED INTO UNIT # 1. DRIVER OF UNIT # 1 STATED HE WAS STOPPED AT THE LIGHT AND HIT FROM BEHIND BY UNIT # 2, AFTER UNIT # 2 WAS HIT BY UNIT # 3. DRIVER OF UNIT # 3 STATED SHE WAS BEHIND UNIT 1 & 2, COMING DOWN THE HILL TOWARDS THE STOP LIGHT, AND WAS SLIDING ON THE SNOWY ROADWAY, UNABLE TO STOP IN TIME, AND STRUCK UNIT # 2.
