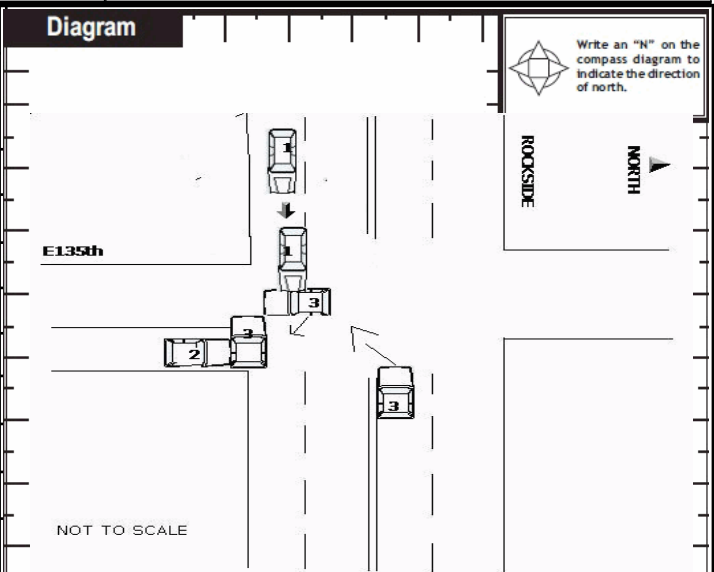

UNIT 1 WAS TRAVELING E/B ON ROCKSIDE RD. IN THE RIGHT LANE. UNIT 3 WAS TRAVELING W/B ON ROCKSIDE RD. IN THE LEFT LANE. UNIT 3 THREE THEN MADE A S/B TURN FROM ROCKSIDE RD. ONTO E.135TH. UNIT 1 THEN STRUCK UNIT 3 WHILE UNIT 3 WAS MAKING IT'S S/B TURN ONTO E.135TH, ON UNIT 3'S RIGHT SIDE. UNIT 3 THEN SPUN FROM THE IMPACT, CAUSING UNIT 3 TO STRIKE UNIT 2, WHILE UNIT 2 WAS STOPPED ON E.135TH AT ROCKSIDE FOR THE STOP SIGN.
