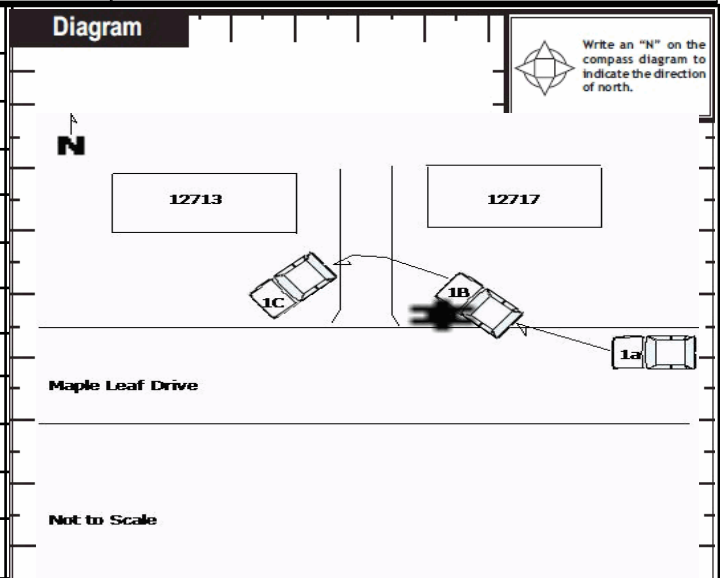



UNIT 1 WAS TRAVELING W/B ON MAPLE LEAF DR. AND STATES ANOTHER VEHICLE WAS APPROACHING FROM THE OPPOSITE DIRECTION. UNIT 1 DRIVER STATES SHE ATTEMPTED TO SLOW DOWN AND MOVE TO THE RIGHT TO AVOID STRIKING THE ONCOMING VEHICLE, DROVE OVER THE CURB AND SIDE SWIPED THE TREE IN THE TREE LAWN AT 12717 MAPLE LEAF. UNIT 1 THEN CONTINUED ACROSS THE FRONT YARD OF 12713 MAPLE LEAF. DAMAGE WAS CAUSED TO THE DRIVER'S SIDE MIRROR AND MINOR DAMAGE TO FRONT LEFT QUARTER PANEL
