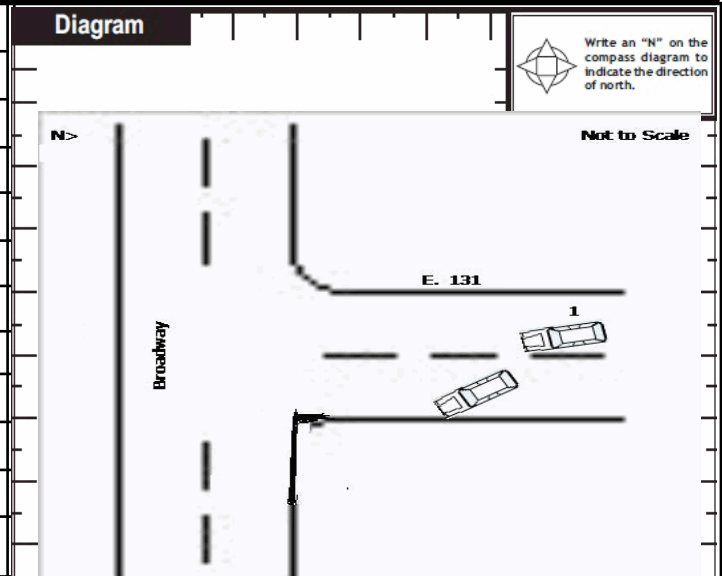

<p>unit 1 was travelling south on E.131 approaching Broadway Ave. Unit 1 lost control on the icy roadway. unit 1 states they went left of center and struck a large snow plow truck that was travelling northbound on E.131. Unit 1 states the plow truck did not stop . GHPD dispatch contacted the Garfield Hts. service garage and inquired on any plows that may have been struck. One driver responded that " a vehicle travelling out of control south on E. 131 almost struck him, but missed the truck and appeared to strike a curb before regaining control. Ptl. Jarzembak and Lt. Vargo met with this driver and observed no damage at all on the truck or plow. It is unknown at this time what exactly unit 1 struck to cause the damage to unit 1. the damage on unit 1 is consistent with having been in an opposite direction sideswipe type mva, or having lost control and striking a curb or other object off the road. Officers checked the area of E. 131 and did not see anything along the roadway that was obviously recently struck.</p>
