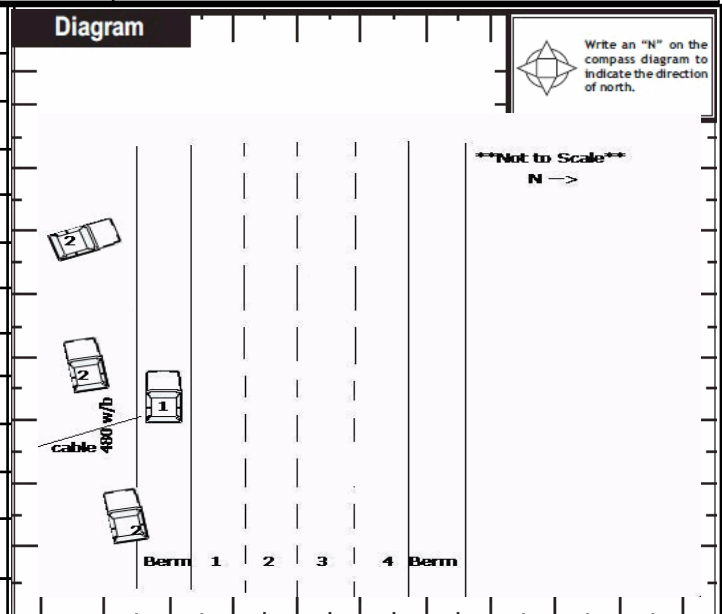

UNIT 1 STATES HE WAS ATTEMPTING TO HOOK THE WINCH CABLE ONTO A VEHICLE THAT WAS STUCK IN THE SNOW. UNIT 1 STATES AT THAT TIME UNIT 2 WAS TRAVELING W/B ON IR 480 IN THE LEFT LANE AND SLID OUT OF CONTROL INTO THE MEDIAN CATCHING THE CABLE. UNIT 1 STATES UNIT 2 THEN SNAPPED THE WINCH CABLE. UNIT 2 STATES SHE OBSERVED UNIT 2 ON THE ROADWAY STOPPED AND ATTEMPTED TO STOP. UNIT 2 STATES SHE THEN SLID AND WENT INTO THE MEDIAN TO AVOID STRIKING UNIT 1. UNIT 2 STATES SHE WAS UNAWARE THAT SHE DAMAGED THE CABLE.
