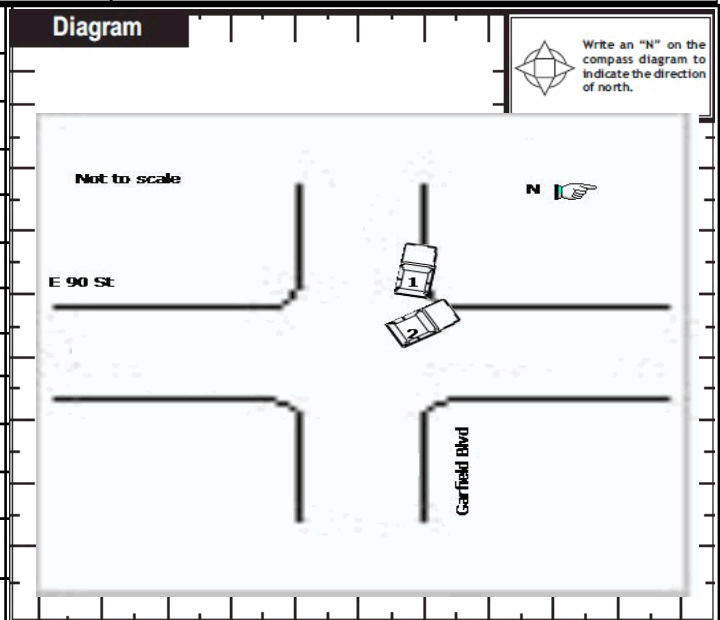

UNITS 1 & 2 WERE TRAVELLING W/B ON GARFIELD BLVD NEAR E 90 ST IN SNOWY, SLIPPERY CONDITIONS WHEN UNIT 1 BEGAN TO SPIN. DRIVER OF UNIT 2 STATED HE SAW UNIT 1 LOSE CONTROL AND TRIED TO AVOID IT BUT WAS UNABLE TO AND STRUCK UNIT 1 WHICH CAUSED BOTH CARS TO SPIN AND THE REAR OF UNIT 2 COLLIDED WITH UNIT 1. UNIT 1 THEN WENT UP AND OVER THE RIGHT HAND CURB. BOTH CARS CAME TO A REST.


