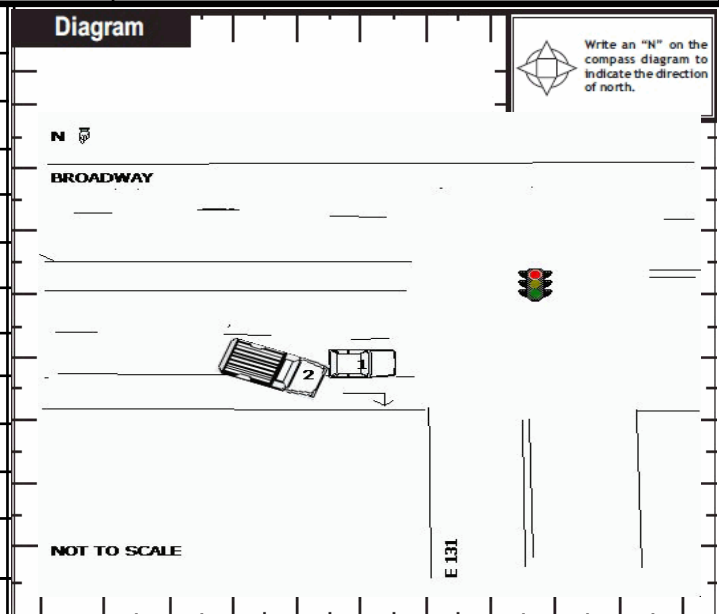
Narrative

UNIT 1 WAS E/B ON BROADWAY AT E 131 IN CENTER LANE.

UNIT 2 WAS BEHIND UNIT 1. UNIT 1 STOPPED DUE TO APPROACHING EMERGENCY VEHICLES. UNIT 2 WAS UNABLE TO STOP IN TIME, VEERED TO THE RIGHT AND STRUCK UNIT 1 IN THE REAR

UNIT 2 STATES HE WAS IN CENTER LANE APPROACHING E 131. STATES UNIT 1 WAS IN CURB LANE. UNIT 1 THEN IMPROPERLY CHANGED LANES INTO CENTER LANE AND ABRUPTLY STOPPED DUE TO APPROACHING EMERGENCY VEHICLES. UNIT 2 TRIED TO AVOID UNIT 1 AND VEERED TO THE RIGHT BUT STRUCK UNIT 1 IN THE REAR

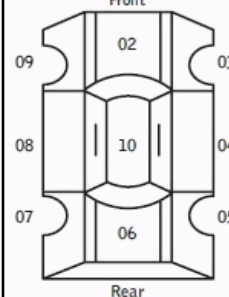
