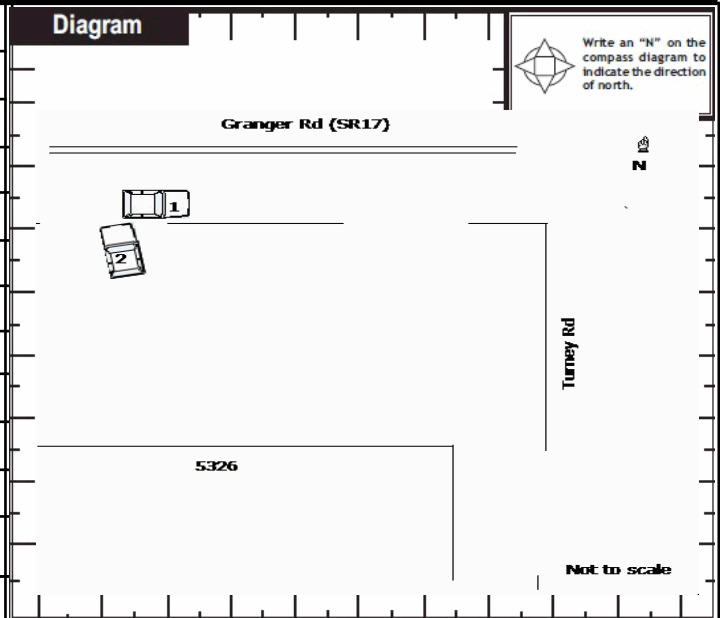

DRIVER OF UNIT 1 STATES HE WAS TRAVELING E/B ON GRANGER (SR17) APPROACHING THE INTERSECTION AT TURNEY RD. HE BEGAN TO SLOW FOR TRAFFIC THAT WAS STOPPED IN FRONT OF HIM AND WAS STRUCK BY UNIT 2 AS IT EXITED THE PARKING LOT OF 5326 TURNEY RD.

DRIVER OF UNIT 2 STATES THAT SHE WAS EXITING THE PARKING LOT OF 5326 FROM THE WESTERN MOST EXIT / ENTRANCE. SHE LOOKED AND DID NOT SEE UNIT 1 HAD STOPPED AND BELIEVED IT WAS STILL MOVING. SHE THEN PULLED INTO THE LANE OF TRAFFIC OF UNIT 1 AND STRUCK THE REAR OF UNIT 1 AS SHE ENTERED THE ROADWAY.
