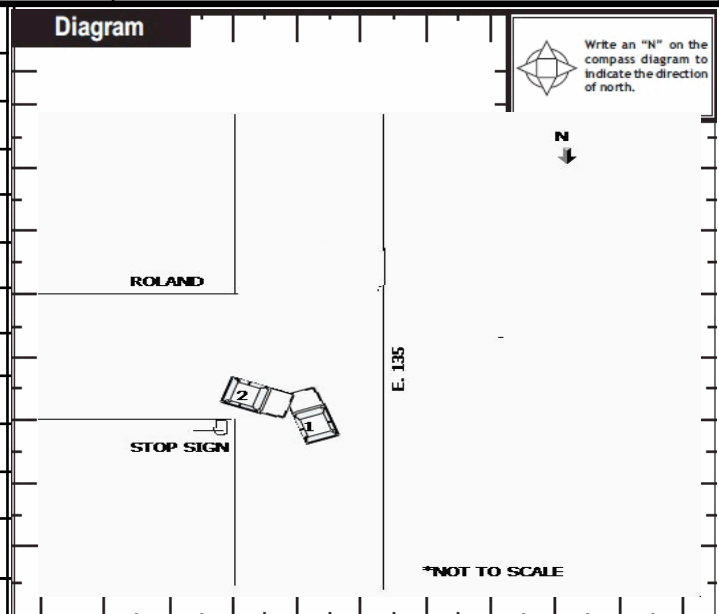

UNIT #1 WAS TRAVELLING S/B ON E. 135. UNIT #1 STOPPED AND BEGAN TO TURN LEFT AT ROLAND. THE DRIVER OF UNIT #1 STATED UNIT #2 WENT THROUGH THE STOP SIGN AND HIT UNIT #1 AS IT BEGAN TO TURN RIGHT FROM ROLAND ON TO E. 135. THE DRIVER OF UNIT #2 STATED HE STOPPED AT THE STOP SIGN ON ROLAND AND DIDN'T SEE ANOTHER VEHICLE. HE THEN BEGAN TO TURN RIGHT WHEN HE STATED UNIT #1 TURNED INTO HIS VEHICLE. THE DRIVER OF UNIT #2 DIDN'T SPEAK ENGLISH VERY WELL. HIS PASSANGER TRANSLATED. THIS OFFICER DETERMINED UNIT #2 TO BE AT FAULT DUE TO THE DAMAGE TO BOTH VEHICLES. UNIT #2 HAD A STOP SIGN AND UNIT #1 DIDN'T.
