UNIT 1 STATES HE WAS TRAVELING E/B ON MCCRACKEN RD

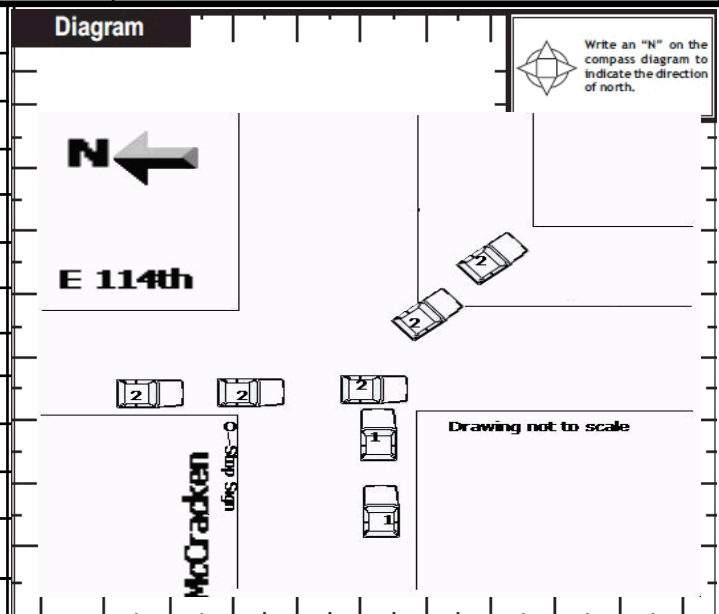
UNIT 1 STATES AS HE APPROACH E 114TH HE OBSERVED


