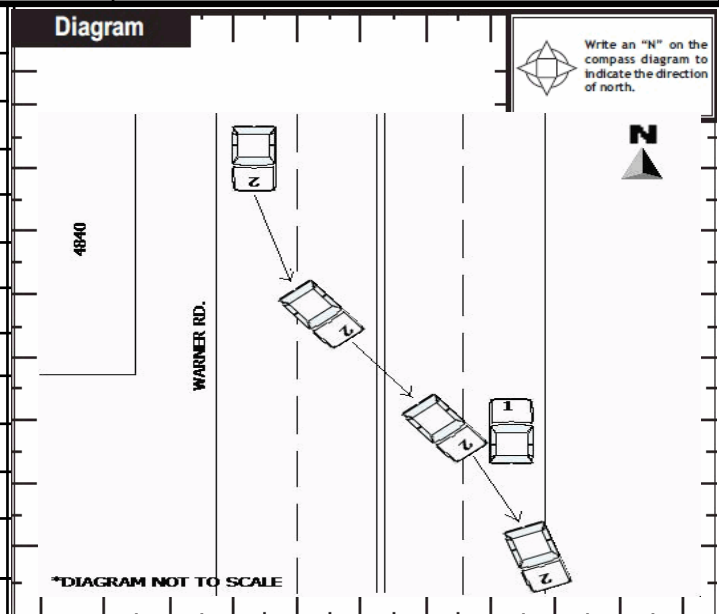

UNIT 1 WAS TRAVELING N/B ON WARNER RD. IN THE CURB LANE APPROACHING 4840. UNIT 2 WAS TRAVELING S/B ON WARNER RD IN THE CURB LANE JUST PASSING 4840. DUE TO A SNOW COVERED ROAD SURFACE UNIT 2 LOST CONTROL CAUSING UNIT 2 TO TRAVEL TO THE LEFT ACROSS THE YELLOW CENTER LINES INTO THE S/B LANES WHERE UNIT 2 STRUCK UNIT 1 IN THE LEFT SIDE. AFTER STRIKING UNIT 1, UNIT 2 CONTINUED TO THE LEFT UP OVER THE CURB OFF OF THE ROADWAY WHERE IT CAME TO REST.
