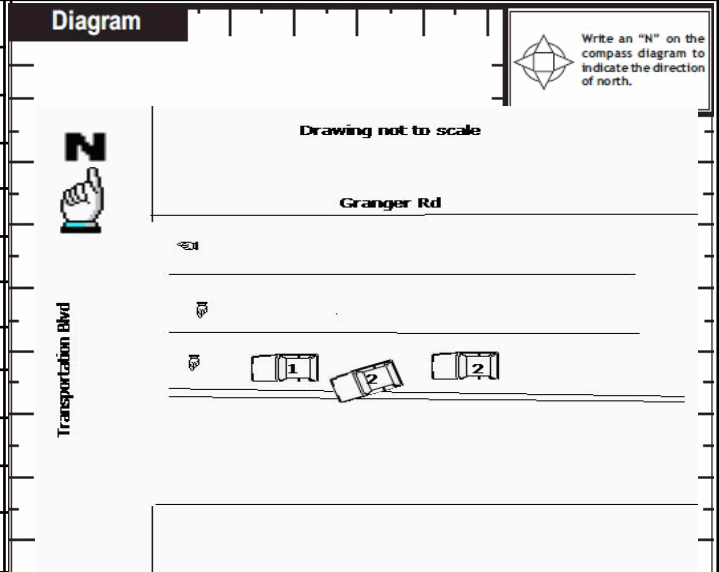

UNIT 1 STATES HE WAS STOPPED ON GRANGER RD AT TRANSPORTATION IN THE TURNING LANE. UNIT 1 STATES WHILE STOPPED HE WAS STRUCK IN THE REAR END BY UNIT 2.

UNIT 2 STATES SHE WAS BEHIND UNIT 1 ATTEMPTING TO STOP. UNIT 2 STATES SHE PUMPED THE BRAKES AND ATTEMPTED TO TURN FROM STRIKING UNIT 2. UNIT 2 STATES SHE WAS UNABLE TO TURN DUE TO A TRUCK IN THE E/B LANE. UNIT 2 STATES SHE THEN STRUCK UNIT 1 IN THE REAR.


