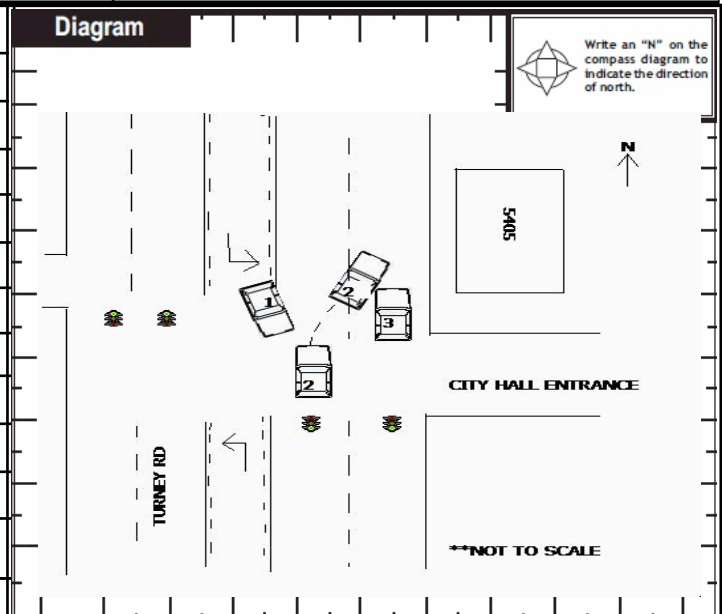

**Narrative**

UNIT 1 WAS S/B ON TURNEY RD AND DROVE INTO THE LEFT TURN LANE NEAR 5405. UNIT 1 ATTEMPTED TO STOP BUT SLID INTO THE N/B LANES, CAUSING UNIT 2, WHICH WAS N/B ON TURNEY TO SWERVE INTO THE CURB LANE TO AVOID A HEAD-ON CRASH. UNIT 2 STRUCK THE LEFT FRONT OF UNIT 3, WHICH WAS N/B ON TURNEY IN THE CURB LANE. THIS OFFICER SWERVED TO AVOID UNIT 1 JUST PRIOR TO UNIT 2 AND WITNESSED SAID CRASH.


