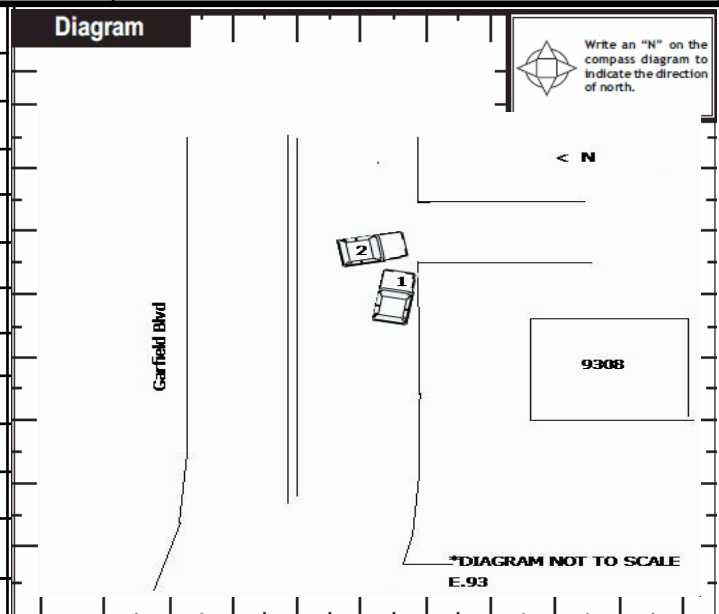

DRIVER OF UNIT 1 STATES HE WAS TRAVELING E/B ON GARFIELD BLVD PASSING E. 93. UNIT 2 WAS TRAVELING E/B ON GARFIELD BLVD JUST AHEAD OF UNIT 1. UNIT 2 TURNED INTO A DRIVEWAY ON THE SOUTH SIDE OF THE ROAD AND TURNED IN FRONT OF UNIT 1 STRIKING THE FRONT END OF UNIT 1.

DRIVER OF UNIT 2 STATES HE WAS TRAVELING E/B ON GARFIELD BLVD AND HAD TURNED FACING A DRIVEWAY NEAR 9308 TO PLOW THE DRIVEWAY AND HE OBSERVED UNIT 1 TRAVELING TOWARD HIM. UNIT 1 APPLIED ITS BRAKES AND DUE TO THE ROAD CONDITIONS SLID INTO UNIT 2.


