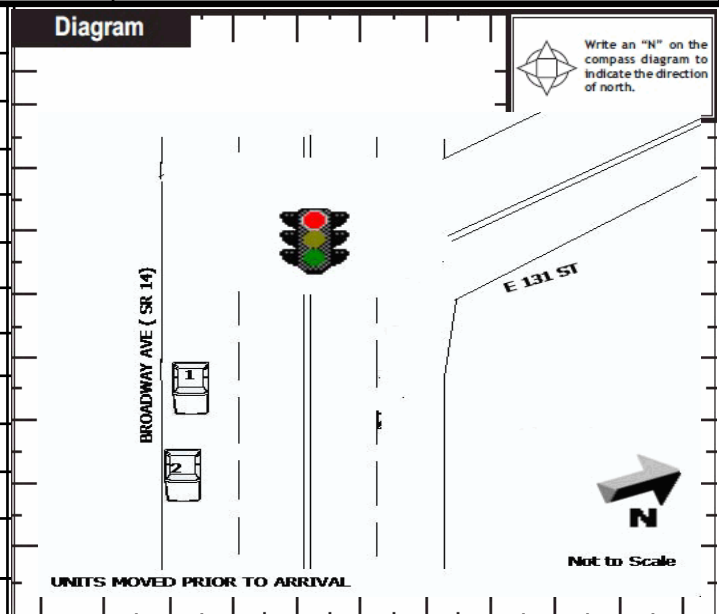

DRIVER OF UNIT 1 STATES SHE WAS EASTBOUND ON BROADWAY AVE (SR 14) IN THE CURB LANE AND APPROACHED THE INTERSECTION WITH E 131 ST WHERE THE TRAFFIC SIGNAL WAS FLASHING YELLOW SHE CONTINUED TRAVELLING EAST THROUGH THE INTERSECTION WHEN STRUCK BY UNIT 2. DRIVER OF UNIT 2 STATES HE WAS SOUTHBOUND ON E 131 ST AT WHERE THE TRAFFIC SIGNAL WAS FLASHING RED HE STOPPED AT THE INTERSECTION THEN CONTINUED BY TURNING LEFT ONTO BROADWAY AVE (SR 14) INTO THE LEFT LANE HEADING EAST WHEN STRUCK BY UNIT 1. UPON ARRIVING ON SCENE OFFICER MARKS OBSERVED THE SIGNAL ON
