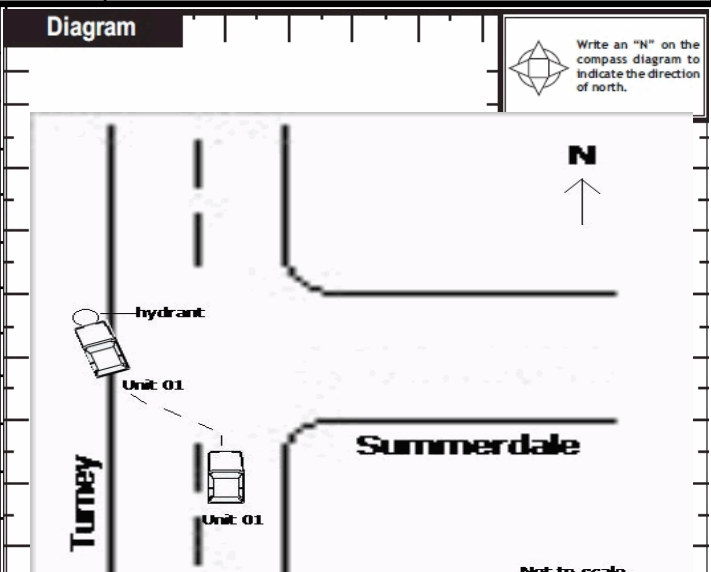

UNIT 01 WAS TRAVELING NORTH ON TURNEY AT SUMMERDALE. UNIT 01 THEN BEGAN TAKING GUN FIRE(SE E GH20180627) FROM THE RIGHT SIDE WHICH STRUCK THE RIGHT/PASSENGER SIDE OF UNIT 01 5 TIMES. UNIT 01 THEN SWERVED LEFT AND INCREASED SPEED TO AVOID THE DANGER. UNIT 01 DROVE OVER THE CURB AND OFF THE ROAD AT WHICH TIME THE CENTER FRONT OF UNIT 01 STRUCK A FIRE HYDRANT ON THE SIDEWALK. UNIT 01 THEN CAME BACK ONTO THE ROADWAY AND FLED THE AREA TRAVELING NORTH ON TURNEY.
