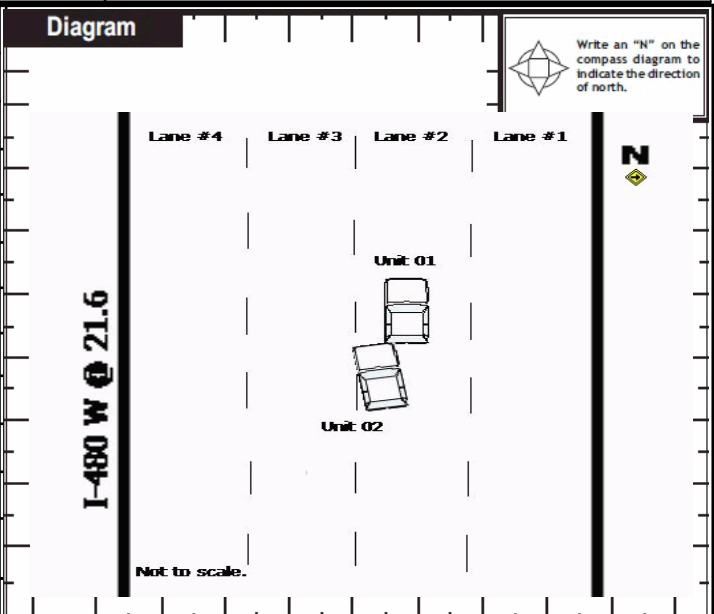

Narrative

UNIT 01 WAS TRAVELING WEST IN LANE #2(FROM THE RIGHT) ON I-480 W AT MILE 21.6, AND UNIT 02 WAS ALSO TRAVELING WEST IN LANE #2 DIRECTLY BEHIND UNIT 01. UNIT 02 ATTEMPTED TO CHANGE LANES TO THE LEFT MOVING INTO LANE #3 TO OVERTAKE UNIT 01, DURING WHICH TIME THE FRONT OF UNIT 02 STRUCK THE LEFT REAR CORNER OF UNIT 01. THE CONTACT INITIATED BY UNIT 02 CAUSED UNIT 01 TO LOSE CONTROL AND SPIN AROUND WITHOUT HITTING ANYTHING ELSE, AND IT CAUSED UNIT 02 TO LOSE CONTROL AND RUN OFF THE RIGHT SIDE OF THE ROAD.
