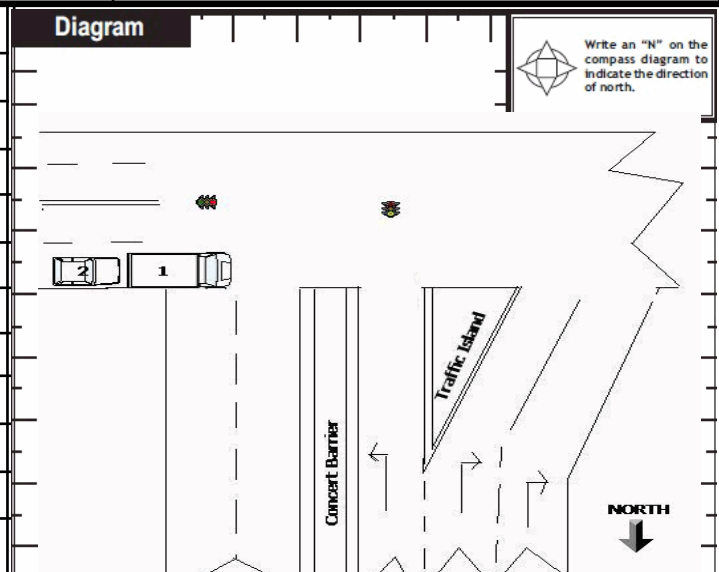

UNIT 1 WAS STOPPED AT A RED TRAFFIC SIGNAL, AT THE INTERSECTION OF BROADWAY AVE. AND THE IR 480 ENTRANCE RAMP, IN THE CURB LANE. UNIT 2 WAS STOPPED BEHIND UNIT 1. UNIT 1 BEGAN TO PULL FORWARD, IN ORDER TO MAKE A RIGHT HAND TURN ON RED. UNIT 1 OBSERVED TRAFFIC AND CAME TO AN ABRUPT STOP. UNIT 2 DID NOT ALLOW ASSURED CLEAR DISTANCE AHEAD AND STRUCK UNIT 1 IN THE REAR.
