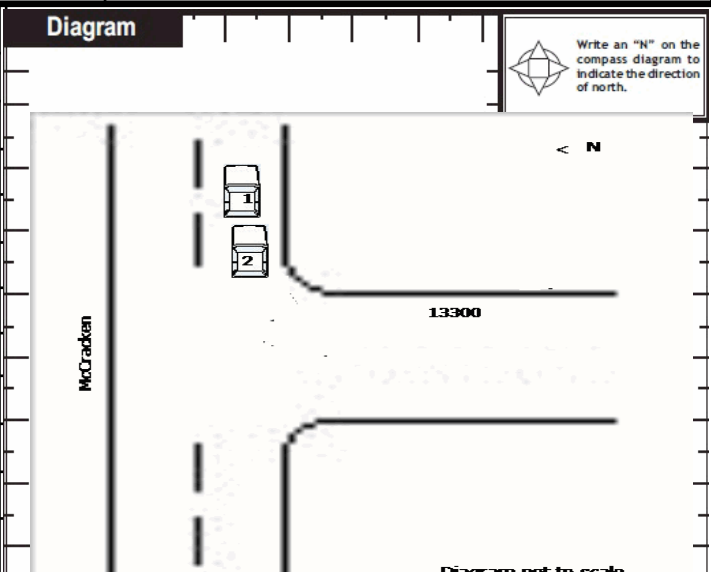

DRIVER OF UNIT 2 STATES SHE WAS TRAVELING E/B ON MCCRACKEN BEHIND UNIT 1. UNIT 1 BEGAN TO SLOW, ACCORDING TO DRIVER OF UNIT 2, FAILED TO ACTIVATE HIS TURN SIGNAL, AND UNIT 2 WAS UNAWARE UNIT 1 HAD COME TO A COMPLETE STOP AND UNIT 2 STRUCK UNIT 1.
