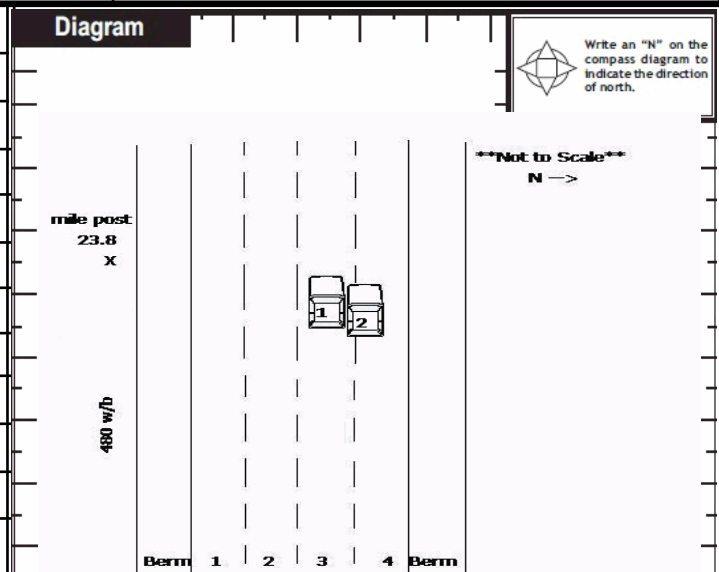

DRIVER OF UNIT #1 WAS TRAVELLING W/B ON IR480 IN LANE 3 AT MILE POST 23.8 AND TRAFFIC WAS HEAVY AND GOING SLOWER THAN NORMAL. UNIT #2 WAS TRAVELLING IN LANE 4 NEXT TO UNIT #1, CHANGED LANES AND STRUCK HIS VEHICLE. THE DRIVER OF UNIT #2 PULLED NEXT TO THE DRIVER OF UNIT #1 AND STATED "THERE'S NO DAMAGE" AND FLED THE CRASH SCENE. BOTH OCCUPANTS OF UNIT #1 CONFIRMED THE DRIVER OF UNIT #2 TO BE THE OWNER OF THAT VEHICLE.


