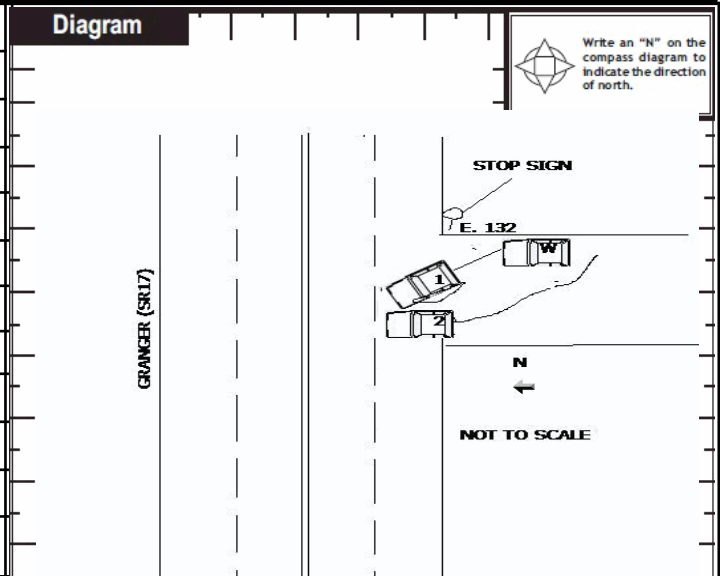

UNIT #1 BEGAN TO MAKE HER TURN WHEN UNIT #2 HAD PULLED OUT STRAIGHT IN FRONT OF UNIT #1 TO TURN LEFT ON TO GRANGER ALSO. UNIT #1 STRUCK UNIT #2. THE DRIVER OF UNIT #1 AND THE WITNESS STATED UNIT #2 WENT LEFT OF CENTER AND PASSED BOTH OF THEIR VEHICLES GOING N/B IN THE S/B LANES ON E. 132 THEN UNIT #2 BEGAN TO GO ON TO GRANGER ROAD. UNIT #1 DIDN'T SEE UNIT #2 UNTIL AFTER SHE HIT THE VEHICLE.




