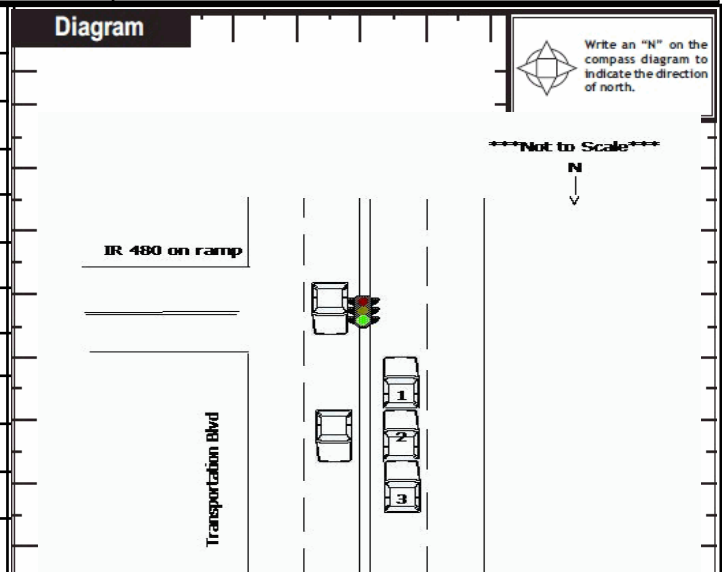

UNIT #1 WAS STOPPED AT THE GREEN LIGHT ON TRANSPORTATION BLVD S/B WAITING FOR TRAFFIC TO CLEAR IN ORDER TO TURN LEFT ONTO IR480 W/B. UNIT #2 WAS DIRECTLY BEHIND UNIT #1 WAITING TO TURN ONTO THE FREEWAY. DRIVER OF UNIT #3 STATED SHE COULDN'T SEE TRAFFIC STOPPED AHEAD DUE TO THE SUN GLARE, THUS HER VEHICLE STRUCK UNIT #2. WHEN UNIT #2 WAS STRUCK, IT WAS PUSHED INTO UNIT #1.


