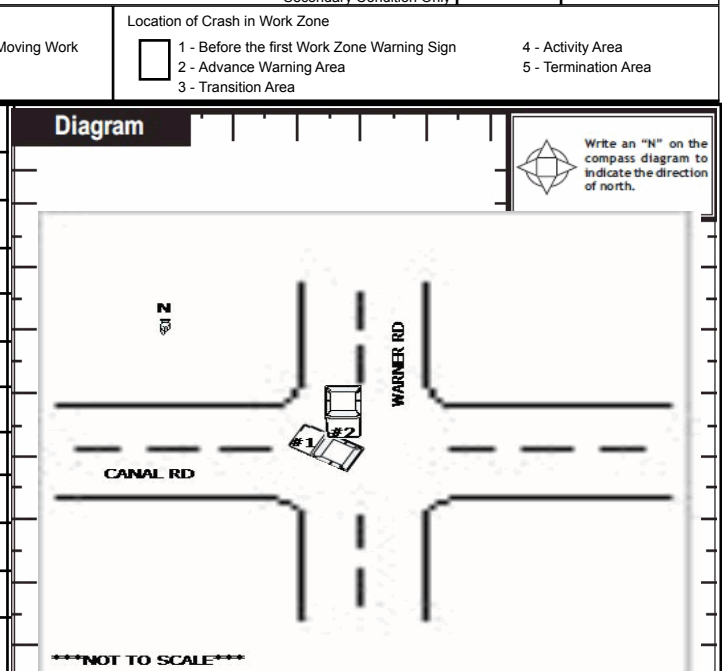

UNIT #1 WAS S/B ON WARNER RD. AT THE INTERSECTION OF CANAL RD. AND WAS IN THE INTERSECTION WAITING FOR THE TRAFFIC TO CLEAR BEFORE TURNING LEFT. THE TRAFFIC LIGHT TURNED YELLOW FOR UNIT #1 AND UNIT #1 TURNED LEFT IN FRONT OF UNIT #2, CAUSING UNIT #2 TO STRIKE UNIT #1. UNIT #2 WAS N/B ON WARNER RD. PRIOR TO ENTERING THE INTERSECTION OF CANAL RD.
