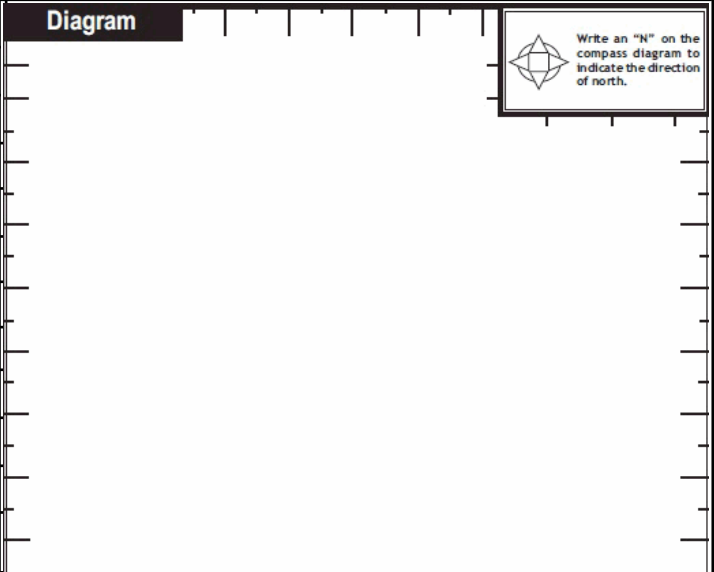

UNIT 1 WAS E/B IN THE PARKING LOT AT 12763 ROCKSIDE.

UNIT 1 SLOWED TO A STOP AS IT CAME TO THE INTERSECTION. UNIT 2 THEN BEGAN BACKING S/B AND STRUCK UNIT 1 ON DRIVER'S SIDE REAR. DRIVER OF UNIT 1 STATED THAT HE GOT OUT OF HIS CAR AND TOLD THE DRIVER OF UNIT 2 THAT SHE HIT HIM. SHE DENIED IT AND DROVE OFF WITHOUT GIVING ANY INFORMATION. HE TOOK A PHOTO OF HER LICENSE PLATE. THE SECURITY VIDEO FROM SAV A LOT CLEARLY SHOWS UNIT 2 STRIKING UNIT 1.
