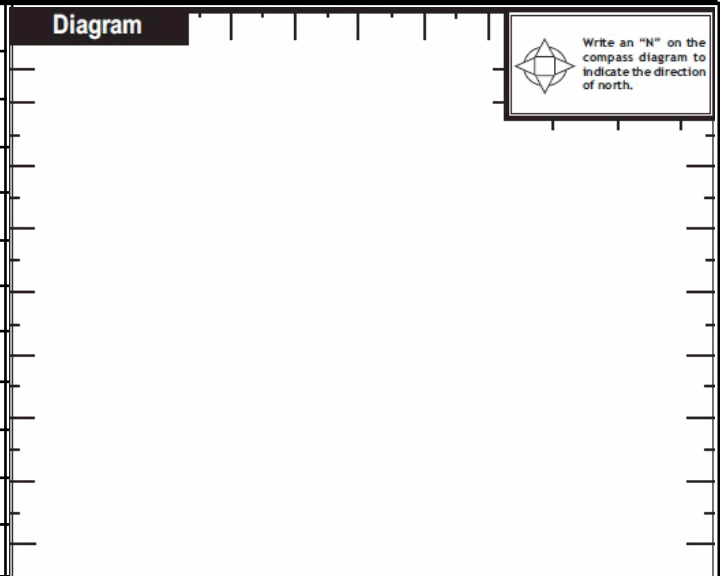

DRIVER OF UNIT 1 STATES THAT HE WAS TRAVELING N/B THROUGH THE PARKING LOT OF 4541 E. 131 (OPEN PANTRY) AND UNIT 2 REVERSED FROM A PARKING SPOT AND STRUCK UNIT 1. BOTH PARTIES SPOKE BRIEFLY AND EXCHANGED INFORMATION, HOWEVER THE DRIVER OF UNIT 2 FAILED TO GIVE HER NAME AND INSTEAD GAVE THE NAME OF THE OWNER OF THE UNIT 2. DRIVER OF UNIT 2 WAS LOCATED AND STATED THAT SHE WAS PARKED IN FRONT OF THE STORE AND HAD REVERSED FROM HER PARKING SPOT IN THE LOT AND BEGAN TO PULL FORWARD NEAR THE EXIT LEADING TO E . 131 AND SHE WAS UNAWARE OF WHERE UNIT 1 CAME
