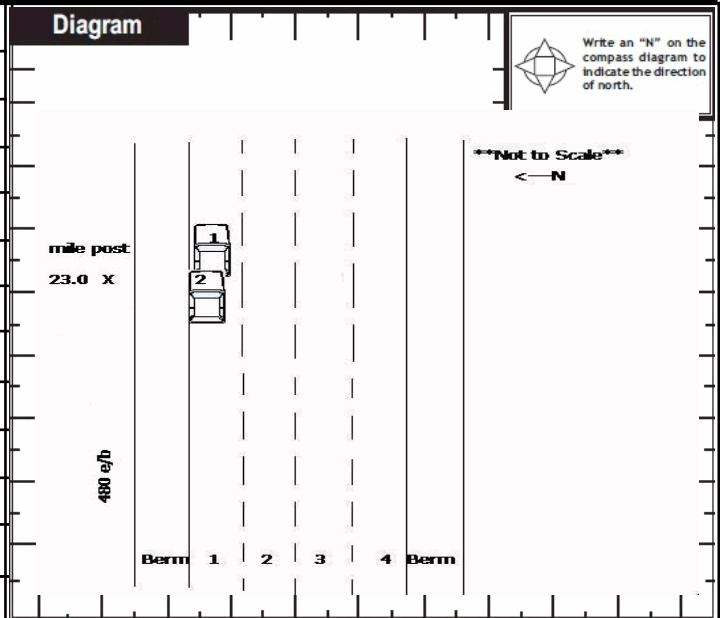

DRIVER OF UNIT #1 STATED HE WAS TRAVELLING IN HEAVY TRAFFIC ON IR480 E/B IN LANE #1 AT MILE POST 23.0. HE SLOWED DOWN, ALMOST TO A STOP, FOR TRAFFIC AHEAD AND WAS REAR-ENDED BY UNIT #2. DRIVER OF UNIT #2 STATED SHE WAS DIRECTLY BEHIND UNIT #1, DIDN'T NOTICE TRAFFIC AHEAD STOPPING, AND SHE SLAMMED ON THE BRAKES. DUE TO THE WET PAVEMENT AND FOLLOWING TOO CLOSE, HER VEHICLE REAR-ENDED UNIT #1.
