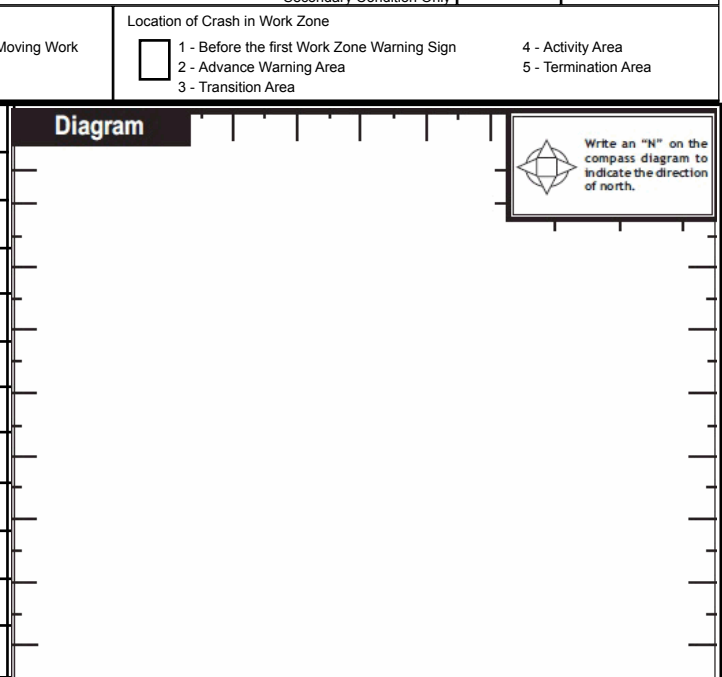

DRIVER OF UNIT 1 STATES HE PULLED TO PUMP 1 IN THE LOT OF 5637 TRANSPORTATION (GETGO) AND WAS WAITING FOR A VEHICLE IN FRONT OF HIM TO FINISH PUMPING GAS. THAT VEHICLE THEN LEFT AND DRIVER OF UNIT 1 WAS LOOKING AT HIS PHONE AND WAS UNAWARE THE VEHICLE HAD LEFT. UNIT 2 THEN ENTERED THE LOT AND PROCEEDED TO PULL UP TO THE PUMP IN FRONT OF UNIT 1. UNIT 2 THEN BEGAN SOUNDING ITS HORN TO GET UNIT 1 TO MOVE. UNIT 1 WOULD NOT MOVE AND UNIT 2 BEGAN MOVING FORWARD AND EVENTUALLY STRUCK UNIT 1.





When she finally turned completely around she observed both vehicles "nose to nose" but was unsure if they had made contact. Krug also advised that prior to hearing the horn and yelling she did observe unit 1 parked near the pump. Unit 2 is observed entering the lot from the southern most entrance and appears to pause for a moment. The car that was in front of unit 1 then leaves the pump and unit 1 stays stationary in its original position turned slightly s/w in approximately 8-10ft from the pump. Unit 2 is then observed pulling forward to position next to the pump and stops. Unit 2 then moves slightly forward several times and appears to get very close to unit 1. However it was unable to be determined from the video if the two units did in fact make contact. Once unit 2 comes to a final stop, the driver of unit 1 can be seen exiting his vehicle and approaches the passenger side window of unit 2. It appears that they two drivers have a brief conversation and unit 2 is observed backing away from the pump.</p>
