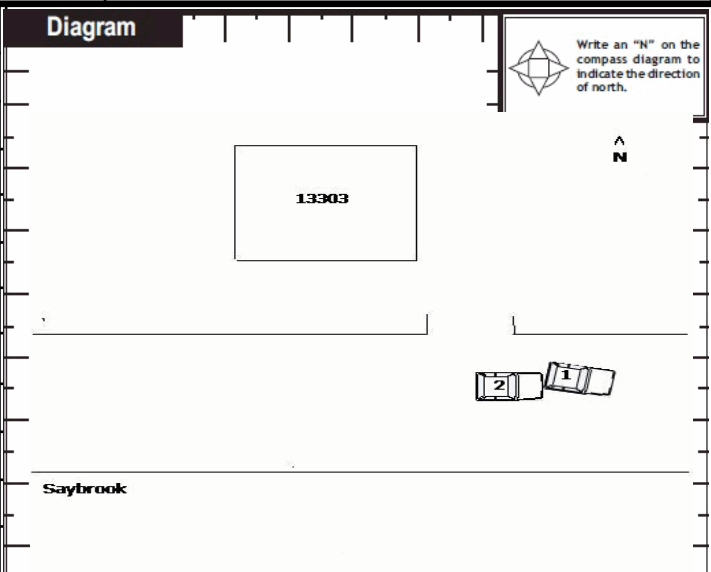

DRIVER OF UNIT 1 STATES HE WAS TRAVELING E/B ON SAYBROOK AND PULLED SLIGHTLY INTO THE W/B LANE OF TRAVEL TO REVERSE INTO THE DRIVEWAY OF 13303 SAYBROOK. UNIT 1 STOPPED PRIOR TO REVERSING AFTER SEEING UNIT 2 BEHIND HIM AND STATES THAT UNIT 2 THEN ENTERED INTO THE W/B LANE OF TRAVEL BEHIND UNIT 1 AND STRUCK UNIT 1 IN THE REAR. BOTH UNITS PULLED TO THE SIDE OF THE ROAD AND AS DRIVER OF UNIT 1 BEGAN TO EXIT HIS VEHICLE TO SPEAK WITH THE OTHER PARTY INVOLVED UNIT 2 LEFT THE AREA. UNIT 1 FOLLOWED UNIT 2 FOR A BRIEF TIME TO OBTAIN THE LICENSE PLATE.

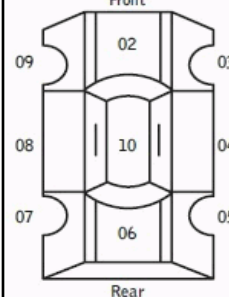
