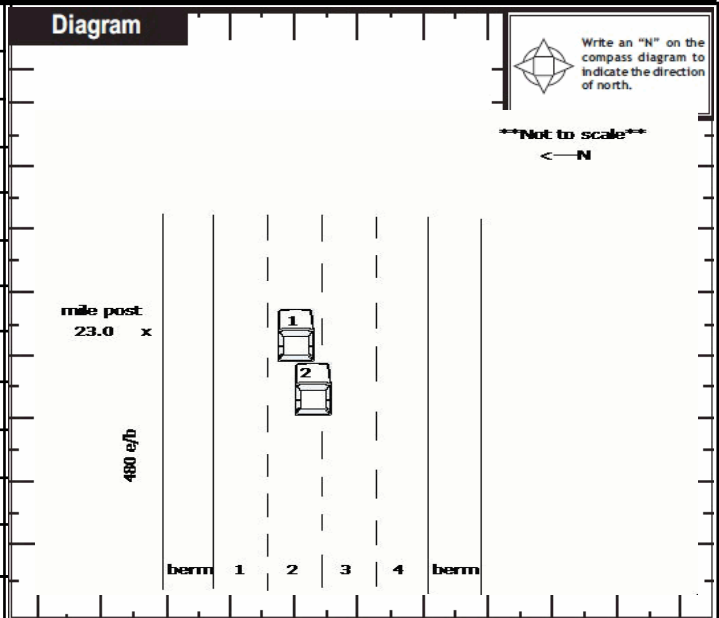

BOTH CARS HAD MINOR DAMAGE AND WERE ABLE TO BE DRIVEN AWAY AFTER THE CRASH.




