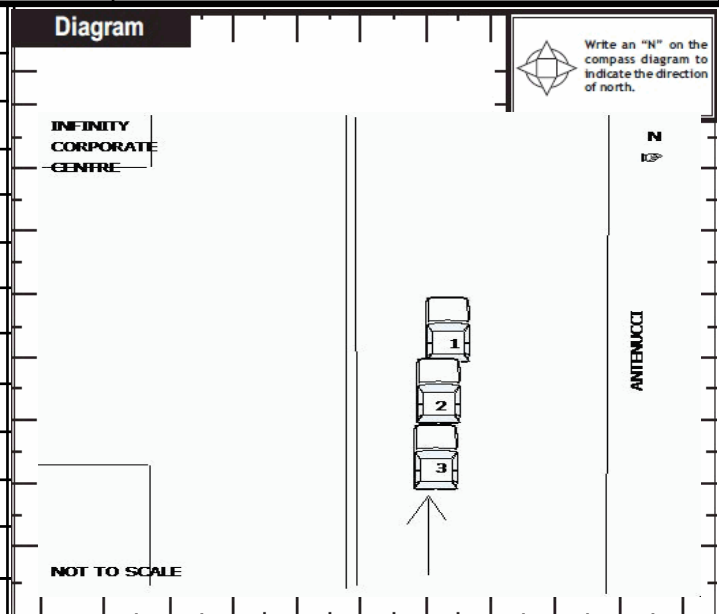

UNIT 1 WAS STOPPED IN WESTBOUND TRAFFIC ON ANTENUCCI AT INFINITY CORPORATE CENTRE DRIVE. UNIT 2 WAS STOPPED BEHIND UNIT 1. UNIT 3 WAS ALSO TRAVELING WEST ON ANTENUCCI BEHIND UNIT 2 BUT FAILED TO MAINTAIN AN ASSURED CLEAR DISTANCE FROM UNIT 2 AND STRUCK UNIT 2 IN THE CENTER REAR CAUSING UNIT 2 TO MAKE CONTACT WITH THE CENTER FRONT OF UNIT 2 INTO THE REAR CENTER OF UNIT 1. THE OPERATOR OF UNIT 1 WAS UNABLE TO PROVIDE PROOF OF INSURANCE AT THE TIME OF THE ACCIDENT.
