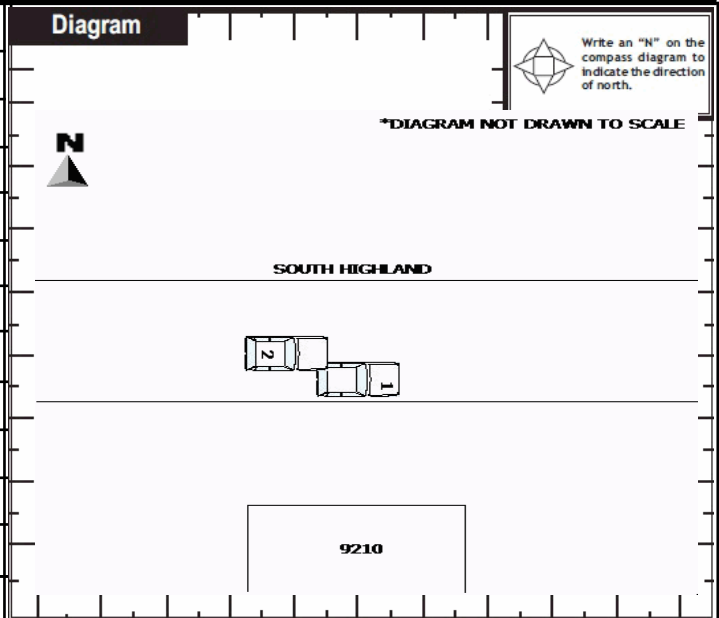

UNIT 1 WAS PARKED ON SOUTH HIGHLAND IN FRONT OF 9210 FACING E/B. UNIT 2 WAS TRAVELING E/B ON SOUTH HIGHLAND APPROACHING UNIT 1. UNIT 2 FAILED TO SAFELY TRAVEL TO THE LEFT OF UNIT 1 TO PASS CAUSING UNIT 2 TO STRIKE UNIT 1 IN THE LEFT REAR SIDE. THE OPERATOR OF UNIT 2 STATED THAT DUE TO SUN GLARE UNIT 1 WAS NOT VISIBLE.


