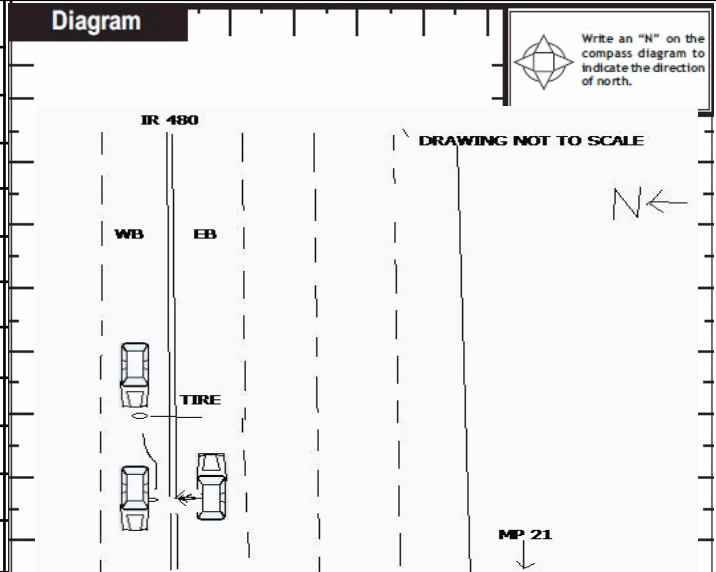

Narrative

UNIT 1 WAS TRAVELLING EASTBOUND ON I 480 JUST PAST MP 21. WHILE OPERATING, THE REAR LEFT TIRE OF UNIT 1 CAME OFF THE VEHICLE. THE RUNAWAY TIRE TRAVELLED ACROSS THE MEDIAN AND INTO THE WESTBOUND TRAFFIC LANES. THE TIRE MADE CONTACT WITH UNIT 2 CAUSING SLIGHT DAMAGE TO UNIT 2. THE TIRE THEN CONTINUED IN THE WESTBOUND LANES STRIKING UNIT 3 IN THE CENTER FRONT. UNIT 3 HAD SIGNIFICANT DISABLING DAMAGE FROM THE TIRE STRIKING IT.
