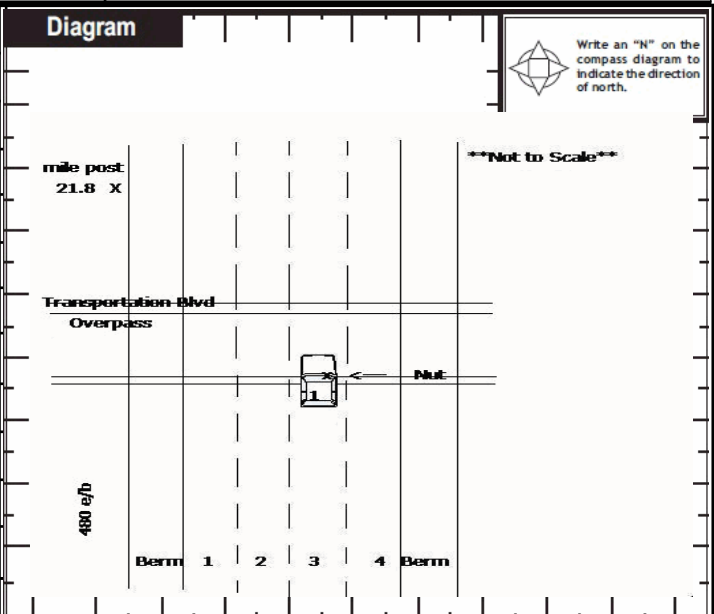

**Narrative**

DRIVER OF UNIT #1 STATED SHE WAS TRAVELLING IN LANE #3 ON IR480 E/B NEAR MILE POST 21.8. AS HER VEHICLE PASSED UNDER THE TRANSPORTATION BLVD BRIDGE THAT WAS BEING WORKED ON, A LARGE 6.31 OUNCE NUT FELL FROM THE CONSTRUCTION AREA AND STRUCK HER WINDSHIELD. THE NUT CAME THROUGH THE FRONT WINDSHIELD ON THE PASSENGER SIDE. GLASS FROM THE IMPACT CUT THE FRONT PASSENGER ON HER ELBOW AND RIGHT SHOULDER. THE NUT WAS TAKEN AND TAGGED AS EVIDENCE.
